ETKİ LİMAN

After being constructed in a record-breaking six months, ETKİ Liman was commissioned in December 2016 to transfer liquefied natural gas imported by ship to the national gas line after being stored and gasified on the vessel known as called Floating Storage & Regasification Unit (FSRU) in accordance with high security and relevant international standards in Kızılburun Location, Çakmaklı Village, Aliağa District in Izmir.

ETKİ Floating LNG Terminal plays a crucial role in responding to seasonal fluctuations in natural gas consumption and serves to protect the system pressure profile of natural gas shipment at a maximum amount from the Terminal to the national system, particularly during peak consumption times and to ensure the security of natural gas supply and supply diversity.

Ankara Railway Station (ATG), Türkiye's first High-Speed Train Station constructed on the Build-Operate-Transfer model, is capable of serving 50k passengers a day with 6 high-speed trainlines and 3 tracks each 400 meters long. ATG has a 134-room hotel, 6k square meters of different-sized office spaces, 25k square meters of rentable retail space and parking lot capacity for 2500 cars. The daily visitor capacity is 100k people.

TEOS MARINA



Located 40 km away from the center of Izmir and 50 km from Adnan Menderes International Airport, Teos Marina is just beside the historical Sığacık Castle and the Ancient City of Teos and only 1 hour away from touristic attraction centers such as Çeşme, Kuşadası, Ephesus, and Church of the Virgin Mary and 2 hours away from Samos Island through ferry services.

Teos Marina, one of the 5 anchor marinas in our country, has received Five Gold Anchors from the Yacht Harbor Association established by the British Marine Federation. Teos Marina has been given a blue flag since the day it was established because of its environmentally friendly services, making it the 10th-ranked marina in the world and second-ranked marina in Türkiye with Five Blue Stars from IMCI (International Marine Certification Institute).

Teos Marina has been constructed on the Build-Operate-Transfer model by the Turkish Ministry of Transportation and Infrastructure in Sığacık, a touristic region of Seferihisar, Türkiye's first **"Cittaslow" (Slow City)**, and was opened in June 2010. It is capable of serving up to 480 boats afloat and 80 boats ashore.

DİKİLİ Port



After being transferred to Dikili Port and Tourism Establishment Trade Inc., by the Privatization Administration in 2003, Dikili Port offers harboring, loading-unloading, terminal services, pilotage, towage, berthing, water supply, waste receiving, lounge, security services under I.S.P.S, and indoor storage outside harbor reach

With state-of-the art technology, the port has embraced service quality conforming to standards and offers services for bulk, bagged, and palletized cargo. The port also offers stockpiling/storage services to importers and exporters in indoor warehouses (31.500 m²) and outdoor yards (22.500 m²) only 5 km away from the port. The loads mainly freighted and discharged on the port include but are not limited to Pearlite, Iron Ore, Clay Minerals, Granite Stone, MDF, Oil Acid and Ammonium Nitrate.





PORT OF ÇANAKKALE

Port of Çanakkale Authority has a 13.622 m³ fuel warehouse at the port, capable of selling marine fuels to ships sailing through the Dardanelles Strait and enjoys a merchant navy of 5 waste collection ships, 3 fuel tankers, 1 agent boat, and 1 berth boat. The Port of Çanakkale (Kepez), commissioned in 2005 on the Build-Operate-Transfer offers cargo handling and terminal services to general cargo, bulk cargo, container, ro-ro ships, and cruises as well as ferries, oil tankers, and chemical tankers as part of international trade. Serving as Çanakkale's marine border crossing, the port not only welcomes cruise ships and provides services for export and import freight but also makes a significant contribution to our sea tourism.

Port of Çanakkale Authority has a 2.688 m² outdoor and a 28.745 m² indoor cargo storage yard. Also embodying the 'Türkiye's Largest' waste receiving facility with a 13.528 m³ tank capacity, Port Authority collects, treats and recycles oil and fuel-based wastes from ships sailing through the Dardanelles Strait in accordance with Marpol Annex 1 while making a significant contribution to the general sustainability principles of Türkiye and the preservation of the seas.

HEKİMHAN MINING

Hekimhan Mining, one of Türkiye's largest investments in the Iron-Steel industry, was established in 2007 to conduct Iron, Chrome, and Manganese Mining. Its calcining plant enriches high manganese, low-impurity siderite ore and serves the domestic and international markets with an unrivaled supply of raw materials.

The only sole facility to enrich iron through calcination, Hekimhan Mining Calcination Factory, processes an iron mine with an annual production capacity of two million tons.



Hekimhan Mining operates the iron mine in Deveci village, Hekimhan district of Malatya, with a production capacity of about two million tons annually. Containing nearly 37% iron and 3,5% manganese, siderite iron ore is processed through calcination to increase the iron concentration to 55% and the manganese content to 6%.

Along with siderite, Hekimhan Mining also provides calcinated siderite, **helping to reduce Türkiye's annual import of iron ore (dust, part, pellet) of 16 million tons.**

Exporting to Romania, Serbia and France, Hekimhan Mining now plans to export to other European countries as well as India and China
